Payments will be made according to guidelines and regulations set forth by FACTS and the Tuition and Fundraising Policies of Saint Lawrence School and as outlined in this letter. Payments are budgeted over 10 months from **July - April**. Payments must be deducted from a checking or savings account. If I choose option 2, I will complete the FACTS Automatic Tuition Payment Agreement form and return it immediately so that I can have the full 10 months to make payments. If I used FACTS last year, I understand that I need to fill out another form for this year. (Fill in all tuition / fees information and be sure to sign the agreement. Note: The signature on the form must match the name on the bank account.)

Unconditional Obligation

I realize that the overhead expenses of the school do not diminish with the departure of any student during the course of the year and that my obligation to pay all fees for the full academic year is unconditional after return of this signed agreement by Saint Lawrence School. Registration fees, deposits and all fundraising monies are non-refundable. If my child leaves the school during the year, the tuition is prorated on a daily basis (based on a 180-day school year). The number of days enrolled times the daily rate is the tuition owed the school at the time of withdrawal. Any refunds will be based on that formula. I also understand that late charges on unpaid balances will be incurred and that in the event of collection by any attorney or other agency, I accept responsibility for, and agree to pay, all additional charges, including a reasonable attorney’s fee.

On May 15th, all slots not secured by a deposit and signed agreement will be opened to those on our waiting list.

Each family agrees to volunteer in grades K-8 (10 hours) -Pre-K (5 hours). Any hours owed will be assessed for \$20 per hour and will be billed as unpaid tuition. All volunteers must be Background Checked and Virtus Trained per the policies of the Archdiocese of Hartford and Saint Lawrence School.
